This EOI does not constitute a solicitation. UNOCI reserves the right to cancel or change the requirement at any time during the EOI or solicitation process. Firms/organizations interested in responding to this EOI and have not yet registered with UNOCI Procurement Section must submit applications for Vendor registration, along with detailed information demonstrating experience and qualifications for the provision of fuel and related services.

Only prospective Vendors that are deemed qualified upon completion of an objective evaluation of their submission will receive the final tender solicitation document. Thus, submitting a reply to this EOI does not automatically guarantee that a firm/organization will be considered for receipt of the solicitation when issued.

**Description of requirement:**

UNOCI intends to issue a Request for Proposal (RFP) for the commencement for the provision of fuel on "**as and when required**" basis. The services to be provided are the provision of bulk fuel (diesel and petrol), dedicated vehicle fuel points, kerosene and ancillary lubricants, and the storage and distribution of aviation fuel to aircraft.

The turn-key fuel operation is to be provided in support of UNOCI,
